Information pursuant to art. 13 of EU Regulation 2016/679 on the protection of personal data updated on 05/25/2018

This information constitutes complete information provided for the video surveillance systems, located at the headquarters in Via Galileo Galilei, 5 20051 Cassina de' Pecchi (MI) Tel +39 02 95906.1 P. Iva 00578910127 / Cod. Fisc. 00740890157 of the company LOGIC S.PA..

The data are processed by computerized means by LOGIC S.P.A., (which processes only the data necessary for the pursuit of each individual purpose and performs on the data only the operations necessary for the pursuit of such purposes) for purposes of protection of persons, property or assets. This is foreseen in order to facilitate in civil or criminal proceedings, possible exercise of the right of defense based on useful images in the event of wrongdoing.

The data may therefore be communicated by LOGIC S.P.A. to the competent authorities (e.g., judicial and police authorities) and to lawyers/legal advisors, and are processed (and thus known as data processors) by persons specifically appointed by LOGIC S.P.A. for LOGIC S.P.A. (concierge staff, security staff, legal staff, employees of the data controller, and maintenance and management staff for the software and hardware components of the facilities).

The data will be kept for the period required by law. Specific security measures are observed by LOGIC S.P.A. to prevent data loss, illicit or incorrect use and unauthorized access.

All the mentioned data are stored and processed by LOGIC S.P.A. in full respect of confidentiality in compliance with all applicable regulations (and therefore also in compliance with the principles of correctness, lawfulness, transparency and protection of confidentiality and rights) and with logics strictly related to the purposes indicated in this information notice.

On the data are carried out by LOGIC S.P.A. only the operations necessary for the pursuit of the purposes indicated in this statement.

The video data will be kept at the headquarters of LOGIC S.P.A. owner of the facility and constituting the figure of Data Controller for 24 hours from the time of their acquisition and subsequently deleted by overwriting. Only during holidays or company closures will the retention of recordings be extended to 48 hours.

The data will reside in Italy.

Article 13 of the GDPR EU 2016/679

- 1. The data subject shall have the right to obtain from the data controller confirmation as to whether or not personal data relating to him or her are being processed and, if so, to obtain access to the personal data and the following information:
- (a) the purposes of the processing;
- (b) the categories of personal data concerned;
- (c) the recipients or categories of recipients to whom the personal data have been or will be disclosed, particularly if recipients in third countries or international organizations;
- (d) when possible, the expected period of retention of personal data or, if this is not possible, the criteria used to determine this period;
- (e) the existence of the data subject's right to request from the data controller the rectification or erasure of personal data or the restriction of processing of personal data concerning him or her or to oppose its processing;
- (f) the right to lodge a complaint with a supervisory authority;
- (g) where the data are not collected from the data subject, all available information about their origin;
- (h) the existence of an automated decision-making process, including profiling as referred to in Article 22(1) and (4), and, at least in such cases, meaningful information about the logic used, as well as the importance and the foreseen consequences of such processing for the data subject.
- 2. Where personal data are transferred to a third country or international organization, the data subject has the right to be informed of the existence of appropriate safeguards under Article 46 relating to the transfer.
- 3. The data controller shall provide a copy of the personal Data being processed. In case of additional copies requested by the data subject, the data controller may charge a reasonable fee based on administrative costs. If the data subject makes the request by electronic means, and unless otherwise specified by the data subject, the information shall be provided in a commonly used electronic format.
- 4. The right to obtain a copy referred to in paragraph 3 shall not harm the rights and freedoms of others.
