

Information for the processing of personal data

In compliance with the provisions of Regulation (EU) 2016/679 (cd. GDPR), this document provides all the necessary information concerning the processing of personal data of the subjects who, during the COVID-19 emergency, so-called Coronavirus, access the offices of Logic S.p.A. or to other places in any case related to Logic S.p.A.

Type of personal data processed and interested parties

Within the limits of the purposes and methods defined in this information, the following data are processed:

- a) data relating to body temperature;
- b) information on close contacts at high risk of exposure, in the last 14 days, with subjects suspected or positive COVID-19 results;
- c) information on the origin, in the last 14 days, from risk areas according to the indications of the OMS.

The personal data being processed refer to:

- a) the staff of Logic S.p.A. with respect to these interested parties, this information supplement that already provided for the processing of personal data functional to the establishment and execution of the employment relationship;
- b) suppliers, couriers, contractors, visitors and any other third party authorized to access in Logic S.p.A. company or to other places in any case related to the latter.

Purpose and legal basis of the processing

Personal data will be processed exclusively for the purpose of preventing COVID-19 contagion, in execution of the anti-contagion security protocol adopted pursuant to art. 1, no. 7, lett. d) of the DPCM of 11 March 2020.

The legal basis of the processing is, therefore, to be found in the implementation of the anti-contagion security protocols pursuant to art. art. 1, no. 7, lett. d) of the DPCM of 11 March 2020 and subsequent amendments and additions.



Nature of the provision of personal data

The provision of data is necessary to access the premises and offices of Logic S.p.A. or to other places in any case related to the latter. Any refusal to give them prevents you from allowing entry.

Method, scope and duration of the processing

The processing is carried out by the staff of Logic S.p.A. acting on the basis of specific instructions provided regarding the purposes and methods of processing.

With reference to the detected body temperature, Logic S.p.A. does not record any data. The identification of the interested party and the recording of the exceeding of the temperature threshold could take place only if it was necessary to document the reasons that prevented access. In this case, the interested party will be informed of the circumstance.

Personal data will not be disseminated or communicated to third parties, except on the basis of specific regulatory provisions (eg in the event of a request by the Health Authority for the reconstruction of the supply chain of any close contacts of a positive worker to COVID-19).

The data will be processed for the time strictly necessary to pursue the above mentioned purpose of preventing the contagion from COVID-19 and stored no later than the term of the state of emergency, currently set at 30 April 2021 by the Decree Law of 14 January 2021 no.2.

Rights of interested parties

At any time, interested parties have the right to access their personal data, to request its correction, updating and the possible related cancellation. It is also possible to oppose to the processing and request its limitation. Furthermore, in the event that the processing is believed to have been carried out in violation of the legislation on the protection of personal data, it is recognised the right to lodge a complaint with the Guarantor Authority for the protection of personal data, Piazza Venezia, 11 - 00187 – Rome.
